1. Bill opened the meeting at 7 pm
2. Bill distributed minutes of the August 3rd meeting and motion by Mike Schieder and seconded by Dave Wiltsie ALL IN FAVOR
3. Walt Zeznick presented the treasurers report which showed a revenue of \$350.00 and expenses of \$402.84 for rule books, section Official dinners of \$75. This results in a loss to date of \$129.84.
4. Old Business:

 - iv. Reminder that those who have not done the test to get on web site and complete the test. Results need to be forwarded to Mark Levy.
5. New Business:
 - a. The scrimmage in Ellicottville does count as a meeting date
 - b. Question was brought up that an official had to pay for an assessment which was a game fee. There is nothing in our bye laws that covers having to pay to be assessed.
 - c. German is exploring the possibility of getting warm up jackets since we have not had a banquet the last two years. Catt. County is in favor of this idea.
 - d. Mike Schieder brought up the idea of pink shirts for breast cancer awareness and we did do something with this a few years ago in conjunction with Section 6. Bill is going to look into this.
6. Training;
 - a. Bill went over the pregame meeting and stated this is for captains and head coaches and just be done at least 5 minutes before the start of the game. The coin toss should be called by visiting team before coin is tossed in the air and please let the coin hit the ground.
 - b. Officials need the roster from each team at least 5 minutes before the start of the game

 - c. Overtime periods are ten minutes each. There will be 5 minutes between of regulation time and start of first overtime. Two minutes between the first and second overtime period. Coin toss must be completed to see who starts with the ball.
